The permit number for this trial is to be announced, and will be posted at the tack room.

Full refund of entry fees for dogs withdrawn after the closing date, in accordance with Chapter 14, Section 2 of the Field Trial Regulations, will require notification of the field trial secretary prior to the starting time of the stake and appropriate veterinary certification no later than September 27, 2017. Full refunds for bitches in season and injured dogs (with vet. certificate). A \$30 fee for all other scratches received before the start of the stake. No refunds for scratches after the start of the stake.
