### **COVID-19 INFORMATION FOR PURINA SHOW GROUNDS**

DUE TO THE INCREASE IN VARIANTS OF COVID, PCA negotiated with Purina Farms in order to be able to hold our National Specialty, indoors and with spectators, under the following conditions:

ALL ATTENDEES will have to be fully vaccinated against COVID-19, with any vaccine approved by the U.S., Canada or your home country worldwide, and be prepared to show proof of vaccination upon entering the show grounds. People are considered fully vaccinated 2 weeks after their second dose in a 2-dose series, such as the Pfizer or Moderna vaccines, or 2 weeks after a single-dose vaccine, such as Johnson & Johnson's vaccine. If you do not meet these requirements, regardless of your age, you are NOT fully vaccinated. The only EXCEPTION to this requirement is for those children, 12 years old and under, who are unable to be vaccinated due to applicable law.

FACE COVERINGS WILL BE MANDATORY AT ALL TIMES, NO EXCEPTIONS INDOORS: Federal, state, local, and CDC guidelines mandate that masks will be required for all indoor public places for individuals age 5 and older. Masks will be strongly encouraged outdoors, especially in group settings, but not required.

## TEST INFORMATION

**The Test will commence at 8:00 AM.** Dogs may not be entered in more than one test level. The running order will be sent to each exhibitor and will be posted at the site.

**Birds:** Ducks will be used at all tests.

**Prizes:** Duck bands and ribbons for all qualifiers, Purina Pro Plan Small Towels offered by Pro Plan, Pro Plan Samples and Artero Shampoo and Conditioner (drawing to be held from among the qualifiers) offered by Artero USA Inc.

**Bitches in Season and injured dogs:** The test committee must receive scratches prior to the beginning of the stake entered. Bitches in season cannot run and are not allowed on the grounds. A full refund will be available for bitches in season or injured dogs with letter from veterinarian. PCA will not pay any entry service fees.

### **Directions to the Hunt Test Site:**

From I-64 (Hwy 40) take Hwy 94 west toward Defiance, and go approximately 1 mile. Turn right on Hwy D, and go approximately 2 miles to entrance to the Busch area on your right. Enter the Conservation area, then turn right again, and then take an immediate left. Proceed to the first right. The Headquarters will be on your left in the large pole building.

**Please note:** You will need to bring your own lunch.

- Electronic collars are not permitted.
- Please keep cell phones on silent mode.

Please air/exercise your dogs away from the test location and those areas where there is likely to be foot traffic. **PICK UP after your dog.**

**No un-entered dogs loose, please.**

**24 hours prior to the start of the test**, only the judges and hunt test committee will be allowed on the grounds. There will be no training at the test location on the grounds 24 hours prior to the test date.
