**TEST INFORMATION**

**The Test will commence at 8:00 AM.** Dogs may not be entered in more than one test level. The running order will be sent to each exhibitor and will be posted at the site.

**Birds:** Ducks will be used at all tests.

**Prizes:** Duck bands and ribbons for all qualifiers.

**Bitches in Season and injured dogs:** The test committee must receive scratches prior to the beginning of the stake entered. Bitches in season cannot run and are not allowed on the grounds. A full refund will be available for bitches in season or injured dogs with letter from veterinarian.

**Directions to the Hunt Test Site:**

From I-64 (Hwy 40) take Hwy 94 west toward Defiance, and go approximately 1 mile. Turn right on Hwy D, and go approximately 2 miles to entrance to the Busch area on your right. Enter the Conservation area, then turn right again, and then take an immediate left. Proceed to the first right. The Headquarters will be on your left in the large pole building.

- Electronic collars are not permitted.
- Please keep cell phones on silent mode.

**No un-entered dogs loose, please.**

**24 hours prior to the start of the test**, only the judges and hunt test committee will be allowed on the grounds. There will be no training at the test location on the grounds 24 hours prior to the test date.
