The Poodle Club of America, Inc., prohibits commercial photography at its events without prior written consent of the Show Chair. For the purposes of this application, a commercial photographer is anyone who sells still and/or moving images captured on the grounds of a PCA event on film, videotape, digital video disc or any other medium.

Commercial photographers that do not accept payment on the grounds of a PCA event are not charged a vendor fee. Those commercial photographers that choose to accept payment on the grounds of a PCA event are subject to the standard PCA vendor fee. Please note that PCA does not grant exclusive rights to any commercial photographer.

Approval of this application grants access to the show site during show hours, solely to act as a commercial photographer. PCA grants no other rights or privileges of any kind or nature to the Commercial Photographer, including, without limitation, the right to use the names, images, voices, biographical materials or other rights of any person, dog or organization.

By this application, the applicant agrees that neither s/he nor his/her agents will interfere in any way with any dog's performance at the PCA events. Interference is any action that may distract a dog or otherwise impair its performance in an event, including but not limited to:

- use of equipment that causes a distracting noise (e.g., loud shutter action or noisy auto-winder);
- intrusion into the area designated for the dog's performance (e.g., camera and/or parts of the photographer's body intruding into show, obedience, or rally ring; agility course; or the like); and/or
- use of flash equipment indoors in any area other than that designated for this purpose.
