TEST INFORMATION

The Test will commence at 8:00 A.M. The running order will be sent to each exhibitor and will be posted at the site.

Birds: Chuckar Partridge, Pheasants or Pigeons will be used in all tests depending on availability.

Prizes: Standard rosette and gamebird bands to all dogs receiving a qualifying score.

Also from Pro Plan and Artero as follows:

Bitches in Season and injured dogs: Bitches in season cannot run. A full refund will be available for bitches in season or injured dogs, less bird costs, with letter from veterinarian. The test committee must receive any scratches ½ hour before the start of the tests (that means before 7:30 am the day of the test) for a refund.

O'Fallon MO.
